

Terms of Use

Last Updated: October 2025

1. General

1.1. These Terms of Use (the “Terms”) govern your (“You”, “Your” or “User”) access to and use of the website **smart-signals.io** (the “Website”) and the services, content, or tools offered through it (collectively, the “Services”).

1.2. These Terms constitute a legally binding agreement between You and **CLICKWISE MARKETING LTD** (the “Company”, “We”, “Us”, or “Our”). If You do not agree to these Terms, You must immediately stop using the Website and Services.

1.3. By accessing or using the Website, You confirm that You have read, understood, and agreed to be bound by these Terms and Our Privacy Policy, which forms an integral part of this Agreement.

2. Eligibility

2.1. You may use the Website only if all the following apply:

- You are at least 18 years of age;
- You have full legal capacity to enter into binding agreements;
- You are not prohibited by any law or regulation applicable to You from using the Website or Services.

2.2. The Company does not guarantee that the Website complies with the laws of every jurisdiction. You are responsible for ensuring that Your use of the Website is lawful in Your location.

3. Restricted Territories

4. Prohibited Activities

4.1. You agree to use the Website and Services respectfully and lawfully. You shall not:

- Upload, distribute, or transmit any unlawful, harmful, defamatory, obscene, or infringing material;
- Violate any intellectual property rights or privacy rights of others;
- Use the Website to send unsolicited communications or advertisements without prior written consent from the Company;
- Interfere with or disrupt the operation of the Website or its servers;
- Attempt to gain unauthorized access to any portion of the Website or related systems;
- Use automated tools (such as bots or scrapers) to extract data or content;
- Introduce viruses, malware, or any harmful code to the Website;
- Engage in any conduct that violates applicable laws or regulations.

4.2. The Company may, at its discretion, monitor Website activity and suspend or terminate Your access if it reasonably suspects misuse or violation of these Terms.
